

With a looming Medicare physician pay cut of 3.37% in 2024, alarming rates of physician burnout and the passage of unsafe scope of practice expansions, medicine is not just at a crossroads: It is in crisis." It is up to us to push for a more sustainable system - one that preserves patients' access to high-quality physician care, while also helping to prevent future burnout for medical professionals.



*Signed into law in 2018, Oklahoma's Senate Bill 1446 mandates that all physicians complete one hour of CME in pain management per year. To help Oklahoma's physicians better understand how this new law impacts their practice and patients, the Oklahoma State Medical Association is hosting special CMEs in Oklahoma City and Tulsa. This one-hour event offers insight to the legal issues affecting pain management and an overview of the new laws connected with prescribing opioids to patients. All Oklahoma physicians with a DEA license are required to take this one hour course annually.

POPULAR WEIGHT LOSS DRUG'S POTENTIAL FOR TREATING ALCOHOL, ADDICTIVE DISORDERS, HIGHLIGHTED IN OSU, OU RESEARCH

Both Ozempic and Mounjaro are

prescription medications designed for adults with diabetes. Wegovy is used as an

obesity treatment.

University researchers in Oklahoma are excited about the potential impact a popular weight loss medication also could have in treating alcohol and addictive disorders. A team of researchers from the University of Oklahoma and Oklahoma State University announced this week that it has published the first evidence that the drug semaglutide specifically reduces symptoms of alcohol use disorder.

Semaglutide has made headlines as an FDA-approved drug for the treatment of diabetes under the name Ozempic and weight loss under the name Wegovy.

"This research marks a significant step forward in our understanding of the potential therapeutic applications of semaglutide in the field of addiction medicine," said Dr. Jesse Richards, OU assistant professor of medicine and director of obesity medicine. The team said larger,

controlled studies will be needed to validate and expand on the initial findings. One such clinical trial is underway at the OSU Hardesty Center for Clinical Research and Neuroscience in Tulsa.

Richards said the anecdotal evidence about semaglutide's possible effect on alcohol use has been piling up.

"That's one of the big things that brought this up — people were spontaneously reporting this," he said. Richards recalled

one of his patients who used to consume a case of beer over just a few hours at the lake. After starting to use semaglutide for weight loss, he lost all craving for beer and cut back.

"That was the first one that really made me sit up and take notice," Richards said. Also promising, officials said, is that low doses of the medication are producing the reported results.

The team published its initial evidence on Monday in a paper in the Journal of Clinical Psychiatry. The paper outlines the outcomes of six patients who received semaglutide during treatment for weight loss, demonstrating a significant decrease in their test scores that identify alcohol disorders.

Dr. Kyle Simmons, the paper's senior author and professor of pharmacology and physiology at the OSU Center for Health Sciences, is conducting the current clinical trial in Tulsa.

The effort, dubbed STAR (Semaglutide Therapy for Alcohol

Reduction), is funded by the Hardesty Family Foundation and OSU-CHS.

"With the publication of this case series, the stage is set for future clinical trials, such as the STAR studies, which can definitively tell us whether semaglutide is safe and effective for treatment of alcohol use disorder," Simmons said.

A sister study is underway in

Baltimore, funded by the National Institute on Drug Abuse. Richards said the team is motivated in part by what the research could mean for Oklahoma. The state has some of the nation's highest rates of obesity, diabetes and alcohol

intake, with rural, underserved populations

being hit especially hard.

"One of the things that is really driving us is how we may end up helping improve the lives of a lot of Oklahomans who deal with multiple issues," Richards said. "This could help their primary care providers take better care of them."

"It's a medication that addresses a uniquely Oklahoma problem," Simmons said. "Here we have a single medication that may

address some of the long-term health outcomes and consequences of these big public health problems that we have here in Oklahoma." Simmons cautioned, however, that the new research shouldn't prompt people to start requesting the drug to treat alcohol disorders just yet.

"We don't know if it's safe and effective in well-validated trials," he said. "Also, we currently have FDA-approved treatments, and really that's where people should be focusing right now."

"It's important to make that point because I'm worried that patients are going to run out and pressure their providers," he added.

The researchers praised the spirit of teamwork that the effort represents and which they expect to continue. "This is an example of what can happen when our two R-1 research institutions in Oklahoma collaborate," Simmons said.

IN MEMORIAM



John Loring Aldridge, MD TCMS Member Since 1978 (45 Years)

John Loring Aldridge, M.D., age 76, passed away peacefully at his home on November 16, 2023. His family and the Tulsa community is abundantly grateful for his life - a life well-lived. John was born in San Francisco, California in 1947 to John Vernon and Beverly Nan Aldridge. His family moved to Plainview,

Texas, shortly after his birth. After his father's death in 1961, his mother moved the family to Austin, Texas, where he attended McCallum High School and gained life-long friends. He studied geology at The University of Texas at Austin, graduating with a bachelor of science degree in 1970. He graduated from The University of Texas Medical Branch at Galveston in 1975. Following his residency in anesthesiology at Scott & White Medical Center in Temple, Texas, he began his 40 plus year career with St. Francis

Hospital based Associated Anesthesiologists Inc. He married Jeanie Marie Northcutt in 1983. John and Jeanie raised their children, John and Sidney, in Tulsa.

John was a thought leader within his large anesthesia group, of which he was a past president. He was appreciated for his wonderful compassion, willingness and ability to take care of very sick patients, and his famous wit. Before surgery he sought to decrease his patient's stress with much-needed humor. John always researched new ways to alleviate his patient's pain during and after surgery. He was grateful to be able to help patients at such a stressful time in their lives. He was a past president of the Oklahoma Society of Anesthesiologists. John pursued his passion for all things car-related. He maintained an ever-changing group of vintage cars. He collected Cushman motor scooters and was active in the Cushman community, attending meets with his wife, Jeanie, on their beautifully restored scooters.

Dwane Blake Minor, MD TCMS Member Since 1959 (64 Years)

Dwane Blake Minor, MD, long-time Tulsa physician and dermatologist, passed away peacefully at his home on Tuesday morning, November 14 at the age of 97. He was born in Drumright, OK on February 6, 1926 - the first child, and only son to Samuel Basil Minor and Mary Ophelia Bradshaw Minor. Before

reaching the age of 5, his family would move to Cushing, Oklahoma where his father opened a Sinclair oil and gas distribution service. As a teenager, he would assist his dad with his business by picking up and delivering both open and sealed oil and gas drums to gas and service stations in the north-central Oklahoma region. For many years, he liked to point out the reckless mindlessness of a typical adolescent in moving these combustible drums to and from his flatbed truck with a lit cigarette in his mouth. Dwane would go on to complete all 12

years of his primary education in Cushing, serving as class president during his senior year before graduating from Cushing High School in May 1944.

With World War 2 still raging in both Europe and Asia at the time of his high school graduation, he immediately joined the US Navy - shipping out immediately by rail from Oklahoma to basic training in San Diego, CA. From there he reportedly wrote his parents that, "They can't do this to me!," and vowed to contact his congressmen immediately to "make this stop." His formal protest evidently either never materialized, or never reached sympathetic ears, and so he successfully completed the program - hitchhiking afterwards back to Cushing, Oklahoma for a two week leave. At the end of that leave, he hitchhiked back to California in August 1944, this time to San Francisco where he would deploy on a troop ship with 900 of his fellow sailors.


